Eligibility:

The SABA-SC Scholarship will be awarded based on a combination of academic accomplishment and community engagement, including, in particular, contribution to the South Asian community. Applicants must meet the following requirements for eligibility:

Applicants must have completed one year of law school (both part-time and full-time are students eligible) and must be a SABA-SC member to apply. Additionally, the Scholarship recipient must actively participate in SABA-SC for the term of the Scholarship in the following ways:

- Attending at least two other SABA-SC events
- Attending SABA-SC's Gala (optional, but highly encouraged)
